You must register your Disclosable Pecuniary Interests in the Register maintained under Section 29 of the Localism Act 2011 and provide written notification of details to the Council's Monitoring Officer.
2. You must within 28 days of becoming aware of any change to the interests specified above provide written notification to the Council's Monitoring Officer of that change.
3.
