- Resident contacted for information on bury their father's ashes in Tickhill. RESOLVED
   Referred to either St Mary's Church for burial in the Church Graveyard or Bereavement
   Services at City of Doncaster Council for the Closed Cemetery opposite.
- Communication from the organiser of the Malby Miners Memorial Community Group inviting a representative from Tickhill Town Council to lay a floral tribute at the memorial service to mark the 102<sup>nd</sup> anniversary of the 'Black Saturday' disaster on 28<sup>th</sup> July 1923 when a huge methane explosion claimed 27 lives. The memorial will be held on 5<sup>th</sup> July 2025 at 11:00am at the site of the disaster in Stainton. RESOLVED added to April meeting agenda for a representative to be considered.
- Intent Notice of road closure, Narrow Lane, Tickhill from a point 134 meters west of its junction with Oddy Lane in a westerly direction for a distance of 30 meters. 20th April 2025 between 10:00hrs and 16:00hrs RESOLVED Information shared to residents as required
- Intent Notice Church Lane, temporarily suspend the one-way restriction to facilitate residential access only. On or after 4<sup>th</sup> April for a period of 5 days. RESOLVED Information shared to residents as required
- Notice of Uncontested Elections. Election of Councillors for Tickhill Town Council.
   RESOLVED. Circulated to councillors and posted as required.
- Email to notify road closure for the installation of new drainage assets along Lindrick Road from 7<sup>th</sup> April to 11<sup>th</sup> April 2025. Map circulated. **RESOLVED** Information shared to residents as required.
- Email from resident requesting French Pension paperwork signing by Chair to evidence proof of existence. **RESOLVED** Resident to bring paperwork to the meeting on 22<sup>nd</sup> April for signature and stamp prior to the start of the public consultation.
- Full PAT testing report received. **RESOLVED** filed hard copy and digital copy in pavilion documents.
- Email to notify the opening day for Tickhill Castle this year will be Sunday 8<sup>th</sup> June
   2:00pm 4:00pm. RESOLVED Information circulated via social media and poster on public notice board.
- Email from Ward Cllr Greenhalgh updating on the situation with the cast iron sign on Rawson Road which was removed from the house wall when it was replaced with a new street sign in January. CDC have reported that unfortunately it was recycled. RESOLVED responded to ask what can be put in pace to prevent a re-occurrence at other sites in the future.

- Email response from sustainability dept at CDC who manage allotments to confirm they
  will be able to hand over tenant agreements, and details following instruction from the
  legal team to ensure GDPR compliance and also to say that to their knowledge, no soil
  testing has ever been carried out. RESOLVED. Requested soil testing to be carried out
