116.25 CORRESPONDENCE (Appendix 3)

23/07/2025 Email from The Little Fudge Company requesting availability of stand space for the Christmas late night shopping event. **RESOLVED** requested permission to forward details to Tickhill Together who organise the event.

24/07/2025 Complaint from member of the public about the overgrown trees from the rear of the premises on Drury Lane completely obscuring the streetlight making it very dark. **RESOLVED** reported to Ward Cllrs and advised member of the public to report via the report it option on the CDC website

25/07/2025 Email complaint for resident regarding repeated illegal parking on double yellow lines causing an obstruction of view and safety issue for vehicles exiting Tithes Lane onto Sunderland Street. **RESOLVED** reported to City of Doncaster Council (CDC) and Ward Councillors.

25/07/2025 telephone complaints from member of the public (3 x calls) complaining about graffiti on Wong Lane. Graffitti is chalking on pavements on both sides of the road by local children. **RESOLVED** reported to Ward Councillors CDC team visited and cleared the graffiti on 5/07/2025.
