

MEETING OF TICKHILL TOWN COUNCIL 25th NOVEMBER 2025

178.25 CORRESPONDENCE (Appendix 3)

- a. **29/10/2025** Hand delivered letter from Tickhill United Charities requesting whether the Council still wishes to have a representative on the board of trustees. **RESOLVED** added to the agenda for consideration.
- 30/10/2025 Email with Parish letter and associated documents and plans for proposed upgrade to the existing radio base station at Apy Hill Lane. RESOLVED circulated to members.
- c. 03/11/2025 Phone call from resident regarding a tree with a TPO in their garden in the conservation area. Planning to fell the tree was refused by City of Doncaster Council (CDC) earlier this year, approved maintenance work was carried out, however resident still concerned the tree poses a safety hazard. RESOLVED requested resident contact the tree and hedgerows officer at CDC for further advice.
- d. 03/11/2025 Email from resident concerned about the poor state of repair of the bench outside the cemetery on Pinfold Lane/New Road. Emailed Ward Cllrs to establish ownership responsibility for bench. Further investigation by the Chair is that ownership and responsibility for the bench is Highways. RESOLVED link to report the issue to the highways given to the resident and advised to retain reference number.
- e. **04/11/2025** Invitation for the Chair to attend the annual Tickhill & District Male Voice Choir Christmas Concert on 13th December. **RESOLVED** invitation sent to Chair.
- f. 04/11/2025 Communication received from a concerned resident regarding the safety of elderly residents on Pinfold Place, where restricted access caused by parked vehicles is blocking the turning point and limiting access for residents and carers.
 RESOLVED: Resident provided with Ward Councillors' contact details and advised to escalate the matter with them.
- g. **05/11/2025** Charter Review Report received from the working group ahead of the PCJCC meeting. **RESOLVED** forwarded to representatives of the PCJCC and circulated to all members in the agenda pack.
- n. 05/11/2025 Email complaint with photographic evidence of further waste dumping on the site off Wilsic Lane. RESOLVED acknowledge receipt and forwarded to Ward Councillors.
- i. 13/11/2025 Telephone complaint about irresponsible parking in St Mary's Car park restricting access to residential premises at the rear of the car park. Resident claims it is repeat offenders parking for hours on end whilst at work. RESOLVED advised resident car park is not enforceable but to keep a note of repeat offenders if safe to do so.
- 18/11/2025 Email from a member of the public regarding the agenda item 187.25.
 RESOLVED information circulated ahead of the discussion at the meeting.

- k. 19/11/2025 email from resident requesting correct process for replacing a hedge with fencing on own property. RESOLVED given contact details for City of Doncaster Council.
- I. 25/11/2025 Phone call from Primary Care Doncaster looking to run a service from their mobile health van 'Vinnie' in Tickhill and they require accommodation for parking. The unit is a medium sized Peugeot Boxer Van, and if parked sideways usually takes around 3 parking spaces up. Has steps leading to the back and is cordoned off by cones so would possibly take 4 spaces in total to give space to get on. Looking at Mondays and Tuesdays ad hoc for the initial pilot project. This will be offering initial assessments with a physio for patients referred into the program from the local practice. Longer term possibly also look at bringing over our mobile GP service if this is well utilised and the location suits as it is felt this could benefit the local community. Information circulated to members. There was a brief discussion, and members instructed the Clerk to investigate the legalities of finding a suitable location. RESOLVED That following a brief discussion the Clerk will make enquiries into the feasibility of a suitable location.
